MEDIA POLICY:

At a FEDANSA National Executive Committee Meeting that was held on the 06th and the 7th August 2010 in Gauteng, the Have Your Say FEDANSA that is currently on the social block was discussed at length.

We would like to advise you of the FEDANSA National Media Policy, page 28 that can be found in the FEDANSA STANDARD OPERATING PROCEDURE, MANUAL AND DANCESPORT GOVERNANCE.

I quote:

(a) Regulations

i. All registered members of FEDANSA:

(a) are prohibited to conduct debate in a public domain on issues relating to aspects of the sport before a concerted effort is made to consult the relevant management structures;

(b) are prohibited from making statements to the press relating to the management of the Sport without the full permission of the FEDANSA National Executive. This does not include advertising for clubs or classes or editorial/documentary on the achievements of any nature.

ii. All complaints, concerns or ideas are to be put in writing via the Provincial Administration Branch or sent directly to the Office of the President.

iii. Members are requested to participate and contribute both at Provincial and National level in the formulation of policy and management of the Sport. The

success and correct image projection is only possible via affiliates and members' support.

iv. Any infringement of this rule will result in Disciplinary Action taken against the offenders.

Notice is therefore hereby given that no FEDANSA National Executive Committee Member (except the PRO), Provincial Administration Branches, Regional Administration Branches, Clubs, Studios, Colleges, University, athletes or any registered member are allowed to make statements to the media without consent from the National President.

You are also hereby informed that the social chat blog, Have Your Say FEDANSA, is not an official blog of FEDANSA.

Members are hereby cautioned to refrain from making statements to the media or on any social network and should rather register their concerns through the correct forum.

FEDANSA National would not hesitate to take Disciplinary Action against any of its registered members who ignores this letter.
